3. MINUTES FROM THE LAST AGM

4. PRESENTATION OF ACCOUNTS FOR THE YEAR 20/21

MT presented a summary of accounts for 2020/21, which were prepared in accordance with the Companies Act 2006, and identified the major areas of income and expenditure.

7. PCVS 2021 ANNUAL REPORT

CA and LM gave a presentation (attached) summarising the work of PCVS over the year and during the Covid period. LM spoke to the unprecedented challenge of Covid. CA spoke to the work of the Communities Team during Covid. CA thanked the National Lottery and other funders.

LM thanked CA and her team for delivering during the crisis

LM spoke to the work of the Direct Payments, Youth Inspired and Building Better Opportunities. Team.

LM suggested challenges for the future including around burn out. A future strategy would focus on stronger and healthier strategic partnerships. LM thanked Heidi Haxeltine at the Lottery, staff, trustees, and everyone attending.

8. QUESTIONS

FA asked whether PCVS had learned if it had been successful in applying for the infrastructure tender. CA said yes PCVS has won it. LM stressed that this is only £40k contribution towards PCVS services.

FY said that she was impressed by the report presented and relayed her thanks to PCVS board members and staff. She said she was interested in the 5 year strategy and wondered what PCVS is doing to support its staff members. LM registered this point and confirmed that the strategy document prepared by JG would soon be available to the public.
