The Elms SARC Building work

Update on building work from Rebecca Summerskill: SARC Regional Contract Director, East. The SARC building work commenced Monday 27th October and is likely to be ongoing until the middle of January 2026.

What does that mean for our patients?

- Our patients will still receive the same service during this time.
- The SARC service will continue to function as we are now, operational hours are the same we
 will continue to be open 9-9. Cambridgeshire and Peterborough patients will still be seen by
 the Cambridgeshire SARC team.
- Contacting the SARC will still be via our PSS call centre on 0330 223 0099 and they will transfer the call through to the Cambridgeshire team.
- SARC staff will still be on site and available for telephone triage / strategy meetings / MARACs.
- Examinations will not be completed at The Elms whilst building work is ongoing, they will be completed at The Emerald Centre Bedford.
- Police will assist in getting patients to the SARC if required if the patients have reported to the police.
- For our self-referrals we will still see and offer the same service, we will look at what SARC is closest for the patient and if required we can assist with transport costs.

Loughborough University Research – Everyday Business: Addressing Domestic Abuse and Continuing Harm through a Family Court review and reporting mechanism (14th October 2025)

Five years have passed since the publication of the government's Harm Panel report which shed light on the deep-rooted issues within the Family Court in responding to domestic abuse.

I have seen small steps forward in terms of the introduction of Pathfinder Courts, improved guidance for court professionals and heightened activity to raise awareness of domestic abuse. Yet, this new report, drawing on evidence from 300 child arrangement case files, extensive observations of three Family Court sites, interviews with judges and magistrates and focus groups with survivors reveals a disturbing truth: that the level of change required remains largely unfulfilled.

As Domestic Abuse Commissioner for England and Wales, it is my duty to scrutinise the systems that should protect some of the most vulnerable people in society. I have long made clear the reforms needed within family courts to ensure survivors are better protected and supported - and why I am deeply concerned that adult and child victims continue to be put at significant risk.

Despite overwhelming evidence of domestic abuse in most cases —73% in hearings and 87% in case file reviews— my office found evidence of how a pro-contact culture and a failure to recognise abuse contributed to decisions that may have put children in harms way. Affirming what survivors and the domestic abuse sector have long stated.

Survivors repeatedly described how they were dissuaded from raising allegations of domestic abuse as it would have no sway over whether the abusive parent would be granted contact. In nearly half of the cases reviewed, unsupervised overnight contact was ordered. Others said they felt pressured into accepting potentially unsafe child arrangement orders out of fear that if they contested, an even worse outcome would be granted. This is deeply disturbing.

An outdated understanding of domestic abuse amongst some legal professionals frequently saw physical violence and sexual abuse taken more seriously, while coercive and controlling behaviour — which often underpins physical abuse — were often dismissed. This antiquated thinking, coupled with a severe lack of resource and siloed working is leaving many survivors feeling unheard, unsupported, and unprotected.

While this report highlights significant shortcomings, it was encouraging to see pockets of good practice emerging within the family justice system. Some judges, magistrates, solicitors, domestic abuse services and Cafcass staff are working tirelessly under heavy workloads to shield survivors from further harm and to ensure trauma-informed approaches are being integrated into proceedings. These efforts are commendable, but more must be done.

With an ambitious target to halve violence against women and girls within a decade, immediate, meaningful reforms are essential if the family justice system is to play its part in safeguarding victims and supporting the government to achieve this priority. We must see sustainable funding and a firm commitment to a national rollout of Pathfinder Courts across England and Wales, combined with

ministers acting to remove the presumption of parental contact, so that decisions are always taken in children's best interest.

This is not just about improving survivors experience of the Family Court — it is about saving and protecting lives. That is why the necessary funding must be provided to the family court review and reporting mechanism pilot to allow for rigorous oversight and continued accountability. Until these steps are taken, the risk to survivors and their children remains very real. It is time for this to change.

Mum of killed boys says 'law change will save lives'

Claire Throssell's Campaign:

A mother whose sons were killed by their father has said she hopes they would be proud after a decade of campaigning in their names resulted in a promised change in the law on parental contact. Claire Throssell's sons Jack, 12, and Paul, nine, were killed in a house fire started by their father in October 2014, after he was granted access to the boys. Caire, from Penistone, met Prime Minister Sir Keir Starmer on Tuesday 21st October 2025 to discuss changes to the **"presumption of contact"** law, which assumes children benefit from contact with both parents.

The government has now said it will repeal the law under the Children Act 1989, which Claire said "will save so many children's lives".

The news came on the 11th anniversary of her sons' deaths.

The boys had been lured to their father Darren Sykes's home with a new model train set, before he set fire to the building, also killing himself. He had been granted access to his children for five hours a week, despite Claire's evidence that he had previously threatened to kill them and himself.

The Ministry of Justice said while this current presumption could be overturned if there was evidence that a parent could put the child at risk of harm, removing this particular law completely should lead to quicker decisions to restrict the involvement of abusive parents. Claire, who was made an MBE in 2020 for her campaigning on behalf of children subjected to domestic abuse, said presumption had no place in a court of law. "It's not for judges who are strangers to children and only get snapshots of their lives to make decisions that then end their lives," she said. "There is this noise around parental rights but a deafening silence around children's rights."

Speaking to BBC Woman's Hour about her sons, she said: "I was so proud to be their mum.

"It is a privilege to have children, but they are not a God-given right and they have their own feelings and wishes, and so often they are not heard."

She said she had applied to the court for an emergency residency order, stating that their father was capable of killing the boys. She said: "I had lived with him, they had lived with him, I had ended up being punched on my arm and thrown down the stairs with the force of it, the boys had seen that.

"I had to protect the boys and many times I got in the way between the boys and him. There was a red mist in his eyes, he was pure evil."

She had warned authorities that their father was a danger to them.

Claire said the change must come urgently as "children can't wait", "whilst there's no change in place, children are still at risk of dying, children are still at risk of harm," she said.

She said her love for her sons inspired her to keep fighting and she now hoped "that they'd be proud" of her achievement. "It doesn't feel like a victory or a win, but it does feel that there is a change coming in the country, and it will save so many children's lives," she said. "I hope that one day I can go to where they sleep and say to them that all the children around them, all the children in this country, will have a safer, brighter future."

Deputy Prime Minister David Lammy praised Claire, calling her "simply remarkable". "Her courage in the face of unimaginable tragedy, her determination to prevent other families from suffering as she has, and her relentless advocacy for children's safety has been instrumental in bringing about this vital change," he said. "As we mark this important step forward in the law, I pay tribute to her sons, Jack and Paul, whose memory drives our commitment to ensuring no other child suffers a similar fate."

National Drug Awareness Campaign

At the beginning of October, the government launched a new national drugs awareness campaign to alert people to the dangers of ketamine as well as synthetic opioids in counterfeit medicines and adulterated THC vapes.

The campaign highlights particular risks including:

- The potentially irreparable damage ketamine can cause to the bladder
- The dangers of counterfeit medicines containing deadly synthetic opioids purchased online
- The risks from so-called 'THC vapes' that often contain dangerous synthetic cannabinoids like spice rather than THC.

National resources will be available for schools and universities, and local public health teams with content available on FRANK, the drug information website. Influencer content will be posted on social media platforms such as Instagram, TikTok, and Snapchat.
